**SECOND JOINT STATUS REPORT  
PURSUANT TO THE COURT'S  
MARCH 2, 2026 ORDER [DKT. NO.  
29]**

**JOINT STATUS REPORT**

1  
2 On March 2, 2026, this Court issued an order granting the joint stipulation of  
3 Plaintiff Ted Entertainment, Inc. (“TEI”) and Defendant Alexandra Marwa Saber  
4 p/k/a Denims (“Denims”) (collectively, the “Parties”) to stay of the present action  
5 pending the final resolution of the motion to quash of the Doe defendants  
6 (collectively, the “H3Snark Mods”) in the miscellaneous action pending before the  
7 Northern District of California entitled *In re Subpoenas to Reddit, Inc. and Discord,*  
8 *Inc.* (N.D. Cal. Case No. 3:25-mc-80296-SK) (the “Motion to Quash Action”),  
9 which stay was subsequently revised to carve out a motion for partial judgment on  
10 the pleadings proceedings. *See* Dkt. Nos. 29, 32. Pursuant to the March 2, 2026  
11 order, the Parties were required to submit a joint status report within fourteen (14)  
12 days of certain events, including if and when the H3Snark Mods would appeal any  
13 order issued in the Motion to Quash Action.

14 As discussed in the Parties’ first status report, on April 29, 2026, the  
15 Honorable Sallie Kim issued an order denying the H3Snark Mods motion to quash  
16 TEI’s subpoenas to Reddit, Inc. and Discord, Inc. and the H3Snark Mods request for  
17 a protective order (the “4/29/26 Order”). *See* Dkt. No. 40.

18 On May 29, 2026, the H3Snark Mods initiated two appeals of the 4/29/26  
19 Order. First, the H3Snark Mods filed a Notice of Appeal in the Motion to Quash  
20 Action – which initiated an appeal entitled *Ted Entertainment, Inc. v. Doe*  
21 *Defendants* (9th Cir. Case No. 26-3553). Second, the H3Snark Mods filed a Petition  
22 for Writ of Mandamus in a matter entitled *Doe Defendants v. United States District*  
23 *Court for the Northern District of California, San Francisco* (9th Cir. Case No. 26-  
24 3513).
